TRUSTEES NOTES

This year there are new requirements affecting adult communities throughout this state regarding the nomination/ election process for those wishing to run for or wishing to nominate another resident to run for a seat on the Board of Trustees. Included in this newsletter is a complete description of those new regulations.

As reported in last month's newsletter, four Trustees terms expire this year. They are Margaret (Peggy) Dove, Jean (Jeannie) Feola, Salvatore (Sal) Sclama and Arnold (Arnie) Wentworth. All are running for another two year term. If you would like to place either your or another resident's name in nomination, please see the attached guideline (Trustees Election Procedure). These changes have necessitated change to the Election Committee procedures as of February 8, 2018. That resolution is also attached.

Nominees running for a seat on the Board do not run for a specific office within that body. Election places you on the Board and specific offices are voted from within the Board itself.

We still need volunteers to serve on the Election and ADR Committee's (Alternate Dispute Resolution). Your service would be greatly appreciated.

Tree Planting

Spring is around the corner so now would be a good time to remind everyone that if you're planning to plant a tree or shrubs, there are rules for planting. No property boundary lines are

to be formed. They must not block line of vision from intersections or driveways etc. All requests for such plantings must be submitted to the Board of Trustees for approval. See rule # 12 of Rules and Regulations.

Planting a Garden...

A small garden - a maximum of 8' x 10' or 80 sq, ft is permitted when authorized by the Board of Trustees and it must be in a location that does not become unsightly to surrounding areas. It must be maintained and cleaned up after the growing season.

Pet Owners...

Dogs / pets **MUST** be on a leash when outside... They cannot be tied and left alone.

Garbage Collection

Each Monday and Thursday.

Doing some work around the house...

The State of New Jersey Uniform Construction Code Regulations is the rules that govern when and if permits are required. The following are some examples but should not be considered an all inclusive list.

Permits are required if:

- ◆ You cut away a wall or any portion thereof
- ◆ You cut any structural beam or bearing support
- ◆ Construct an addition or make alterations to your home
i.e. - enclosing a porch or patio cover
- ◆ Installing, replacing or re-locating a hot water heater
- ◆ Installing, replacing or re-locating any water drainage or venting
- ◆ Installing of heating or air conditioning systems
- ◆ Installation or upgrading any electrical wiring or plumbing

◆ Permits are not necessary, but permission from the Co-op is if:

- ◆ You add or replace shutters, awnings or railings
- ◆ Installation of Solar tubes
- ◆ Installation of Satellite Dish (TV)
- ◆ Window replacements
- ◆ Residents are required to have their contractor provide a certificate of insurance to the Trustees office before any work is started. If you're having work done call the Maintenance Department and check if any of the above applies to your project.

TRUSTEE ELECTION PROCEDURE

On July 13, 2017 Governor Christie signed a law which make significant changes to the election and voting procedures for New Jersey Community Associations.

This new law was the result of a complaint filed with the Department of Community Affairs (DCA) by a group of residents in Radburn Planned Community located in Fairlawn NJ. The complaint charged that a small group was not following State law and their own by-laws in how members of the Board of Trustees were elected.

DCA conducted an investigation into the complaint and found the charges to be of merit. DCA sent to the legislature a list of revisions to be made to existing laws. The revisions resulted in the new law which has been enacted.

Attached is the revised procedure as recommended by our Attorney. The significant changes are:

1. Must be in good standing as of the nomination deadline which this year is April 20th at 3:00pm

Previously a candidate had to have been in good standing for the entire previous year.

2. Must submit a written nomination for oneself or another Membership Certificate Holder. If nominated by someone else, the Nominee must submit in writing their acceptance or refusal within 7 days.

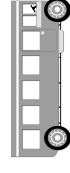
Previously one had to nominate themselves with a petition signed by 25 certificate holders.

3. Only one (1) Certificate Holder per unit may serve on the Board at any given time.

Previously this was not in writing. It was assumed that the one vote per certificate allowed only one per unit to serve.

A Nominee will still need to submit a short bio/resume/qualifications to be published in the Newsletter.

CRESTWOOD VILLAGE ELECTION COMMITTEE

RESOLVED by the Board of Trustees of Crestwood Village Co-op, Inc., at its regular monthly meeting on February 8, 2018, that there be established a Practice and Procedure for the Election of members of the Board of Trustees regarding the following categories:

Campaigning:

1. No door to door campaigning.
2. No advertising on lawns, signs, lamp posts, Co-op grounds or property. (no signs anywhere at all)
3. No campaigning at polling place, clubhouse grounds, parking areas, golf course etc.

Eligibility Requirements to Run for Trustee:

1. Must be listed on membership certificate of Crestwood Village Co-op Inc.
2. Must be in good standing as of the nomination deadline in order to be eligible to run for election to the Crestwood Village One Board of Trustees
3. Must submit a written nomination for oneself or another Membership Certificate holder
4. Only 1 certificate holder per unit may serve on the Board at any given time.

Absentee Ballots:

1. The ballots will be recorded after 3pm on the business day before the election
 - a. The ballots will be recorded, but not the votes
 - b. The votes will be counted with those placed on the day of election.
2. Ballots will be mailed by the office upon request of the certificate holder, not printed in the newsletter bulletin.
3. Ballot must be returned either in person or mailed to the office in a sealed envelope before the cut-off date
4. No corrections or changes can be made on the absentee ballot

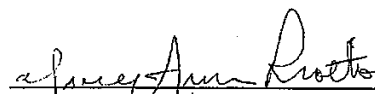
Election Committee:

1. The Election Committee will consist of at least three (3) members
2. Open to all certificate holders in the village current with monies due the Co-op
3. No relative of anyone running for office shall be eligible
4. Election committee should be appointed approximately two (2) months prior to election

Ballots:

1. The ballot shall be printed with the maximum number of votes that may be cast (3 or 4 depending on the election year). Fewer votes can be cast but not more than allowed. Voting for more than allowed will void the ballot
2. In the case of a contested election, a candidate can have a representative present when the votes are counted
3. Corrections can be made on a ballot on day of election, but must be initialed by the chair person
4. A date shall be designated for the candidates to speak to the residents with a question and answer period as well. This shall be offered at the Residents Club meeting and Open meeting.

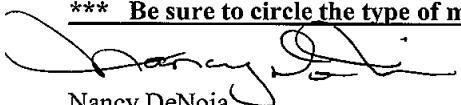
The following information will be helpful when you prepare form PTR-1 and PTR-2, the application for New Jersey Property Tax Reimbursement. This is for the tax freeze. **This is not the NJ Homestead Rebate.**

1. BE SURE TO READ ALL THE QUALIFICATIONS IN THE PTR BOOKLET BEFORE FILING FOR A REIMBURSEMENT.
2. Save this letter, it is the written proof from the Co-Op that you need to show how much was paid in taxes.
Send a copy of this letter with your forms, it will serve as proof and as a verification signature.

Other than supplying the tax figures for our residents, this office doesn't have anything to do with Property Tax Reimbursement. **IF YOU HAVE ANY QUESTIONS, DO NOT CALL THE TRUSTEE'S OFFICE, YOU MUST CALL THE PHONE NUMBER IN THE INSTRUCTION BOOK.**
